Plaintiffs no longer wish to further contest the adequacy of Treasury's search and waive any and all claims that they now have or may hereafter acquire against Treasury, any other department or agency of the United States Government, and any officer employee, or agent of Treasury or the United States Government related to or arising out of Plaintiffs' FOIA Request. 2. This action is hereby dismissed with prejudice, with each party to bear its own fees and costs, provided that the Court shall retain jurisdiction over any issues that may arise relating to this Stipulation and Order. 3. The parties understand and agree that this Stipulation and Order contains the entire agreement between them, and that no statements, representations, promises, agreements, or negotiations, oral or otherwise, between the parties or their counsel that are not included herein shall be of any force or effect.
