**ORDER TO SHOW CAUSE**

Plaintiffs in the instant action (two immigrant-rights organizations and 17 individuals) have filed a complaint challenging the Notice that the Department of Homeland Security (“DHS”) published in the Federal Register on July 23, 2019, which designates undocumented non-citizens who have been in this country for up to two years, and who are located anywhere in the United States, as eligible for “expedited removal” from the United States. (*See* Compl., ECF No, 1, ¶ 8.) *See also* Designating Aliens for Expedited Removal, 84 Fed. Reg. 35,409, 35,409 (July 23, 2019). The instant case was assigned to the undersigned as related to another action pending before this Court, *Make the Road New York v. McAleenan*, No. 19-cv-2369, which likewise challenges the July 23 Notice, and on September 27, 2019 (one week after Plaintiffs filed the instant complaint), this Court issued a Memorandum Opinion and Order in *Make the Road New York* preliminarily enjoining DHS “from enforcing the expedited removal expansion that the Acting DHS Secretary prescribed in the

July 23rd Notice while the instant claims are being litigated, pending further order of this Court.” *Make the Road New York*, No. 19-cv-2369, 2019 WL 4738070, at \*3, (D.D.C. Sept. 27, 2019). This preliminary injunction bars expressly bars DHS from enforcing the expansion with respect to any person, anywhere in the United States, regardless of whether that person is a member of the two organizations who are the plaintiffs in *Make the Road New York*. *See id.* at \*44-49.

In light of this injunction and the overlap between this case and *Make the Road New York*, and in the interest of judicial efficiency, it is hereby

**ORDERED** that, on or before October 22, 2019, Plaintiffs shall **SHOW CAUSE** as to why the instant case should not be **STAYED** pending resolution of proceedings in *Make the Road New York*.
