**JOINT REQUEST TO MODIFY CONSENT DECREE**

On February 5, 2020, the Parties appeared before the Court at a Status Hearing for the purposes of assessing Defendant's compliance with the Consent Decree issued by the Court, and subsequently modified by the Parties. The Parties have recently modified the Consent Decree (Doc. 137), adding additional modifications designed to bring Defendant into compliance. While Defendants remain non-compliant with the terms of the Consent Decree, Defendant has been making some modest improvements in ensuring compliance with the timelines. Additionally,

some of the modifications contained in the Modified Consent Decree had only recently been operative such that it is unlikely that Defendant would have had time to meaningfully address non-compliance. The Court noted that the Plaintiffs, in the Joint Status Report (Doc. 142), had identified certain data deficiencies which were impacting a fulsome analysis of the extent of non-compliance pertaining to the reason why certain patients were not evaluated in the order in which they should have been seen. The Parties were requested to meet and confer about a resolution of this matter. The Parties met and agreed upon a modification to address this issue, which the Court requested the Parties to memorialize in writing. **Accordingly, the Parties jointly request the Court to Modify the Consent Decree to add the following items:**

1: On a monthly basis, the Defendants shall add to the Outpatient Waiting List already provided as part of the Monitoring data two additional data fields containing: a) the County of commitment; and b) a narrative explanation for any person whose evaluation or admission was taken out of numerical order. This new requirement begins in March, 2020.

2: Defendants shall create and provide to ADAP a detailed plan to ensure that Counties which do not contain a congregation of inmates requiring an outpatient evaluation are not indefinitely skipped in favor of Counties containing several inmates. Defendant has expressed a desire to evaluate all of the inmates in a given locale at one time, even if that means that some inmates who have been awaiting an evaluation for a longer period of time are not seen as a method to most expeditiously use valuable resources. However, Defendant may not ignore Counties where few inmates are present indefinitely. The purposes of the plan is to balance the benefit of doing all of the evaluation in a given County contemporaneously, even if that results in evaluations being taken out of order, against the need to ensure that all inmates receive timely evaluations.

The parties agree that the calculation of days to complete an evaluation shall be based upon the actual days required to evaluate the person, even if evaluated out of order, if the Defendant provides a narrative as to why the evaluations were performed out of order, and the narrative indicates that the primary reason was logistical efficiency or other good faith reasons. Defendants shall provide this plan to ADAP by no later than 90 days following the approval of this order.

3: Defendant shall notify the Court as soon as the position of Director of Forensic Mental Health Services has been filled.
