JOINT MOTION FOR ENTRY OF STIPULATED ORDER

This Court held status conferences in this case on October 21, 2014 and November 17, 2014, during which Plaintiff, United States of America, contended that Defendants are not in compliance with the Consent Agreement that was entered on May 22, 2013. *See* Final Order Approving and Entering Consent Decree and Dismissing Case without Prejudice [D.E. 9]. Defendants stipulate that they have not yet achieved full compliance with many of the provisions of the Consent Agreement despite the fact that the completion deadlines for these provisions have passed.

At Plaintiff's request, Defendants prepared a plan for coming into compliance with the provisions of the Consent Agreement with which they have not yet complied ("Compliance Plan") for filing with the Court. At the time of Plaintiff's request, Defendants had already started drafting a compliance document for their own use in ensuring that they would meet the requirements of the Consent Agreement going forward. The parties jointly move that this Court enter the proposed Stipulated Order, attached hereto as Exhibit 1, establishing the Compliance

Plan as an Order of the Court. The parties stipulate that the relief is compliant with the Prison Litigation Reform Act, 18 U.S.C. § 3626(a).

The United States has reviewed the Compliance Plan, attached hereto as Exhibit 2, and believes, at this point, that the entry of a Stipulated Order is the most expeditious route to moving Defendants towards full compliance with the Agreement. However, if Defendants fail to comply with the terms of the Compliance Plan, the United States reserves the right to seek appropriate sanctions from this Court pursuant to the Consent Agreement.

The parties recognize that the entry of the Stipulated Order will have no effect on the Court's ability during the Status Conference planned for January, 2015 to investigate Defendants' efforts to achieve compliance.

CONFERENCE SCHEDULING

During the Court's status conference held on November 17, 2014, the Court and the parties agreed that the next status conference would be held in January, 2015. To this end, the parties respectfully request a Court status conference with all parties on January 27, 2014 at 1:00 pm.

STIPULATED ORDER

THIS MATTER comes before the Court on the parties' "Joint Motion for Entry of Stipulated Order" (Dkt. No. _____), filed on December 17, 2014. In the interests of moving Defendants towards compliance, in an expeditious and efficient manner, with the Consent Agreement (Dkt. No. 9), which was entered as an Order of the Court on May 22, 2013 (Dkt. No. 9), and upon consideration of the current record before the Court, it is hereby

ORDERED that the parties' "Joint Motion for Entry of Stipulated Order" (Dkt. No. ____) is GRANTED; and it is further

ORDERED that, in granting the parties' Joint Motion, the Court finds, as agreed by the parties, that

1. Despite having made good faith efforts to comply, Defendants are non-compliant with the Consent Agreement, entered as an Order of this Court on May 22, 2013; and

2. As a result of Defendants' failure to comply with the Consent Agreement, additional

remedial relief is necessary, as set forth below, and

3. The additional relief set forth below complies in all respects with the provisions of 18

U.S.C. § 3626(a). The relief is narrowly drawn, extends no further than necessary to correct

violations of federal rights agreed to by the parties with the entry of the Consent Agreement, is

the least intrusive means necessary to correct these violations, and will not have an adverse

impact on public safety or the operation of the criminal justice system.

As stipulated by the parties, it is further

ORDERED that the additional relief will consist of the following:

The "Compliance Plan," agreed upon by both Defendants and Plaintiffs and submitted to the

Court along with the parties' Joint Motion on December 17, 2014, including dates by which

Defendants will complete the requirements of the Consent Agreement with which they currently

remain out of compliance, is hereby entered as an Order of the Court, subject to judicial

enforcement.

It is further **ORDERED** that:

4. The entry of this Stipulated Order does not preclude enforcement of the original Consent

Agreement.
