**ORDER**

**DENYING PLAINTIFFS’ MOTION FOR TEMPORARY RESTRAINING ORDER; DIRECTING THE  
PARTIES TO SUBMIT DAILY UPDATES**

On April 2, 2020, Plaintiffs moved for a temporary restraining order that would, *inter alia*, require the “release [of] enough residents” from Hope Village, a halfway house that contracts with both the District of Columbia and the Bureau of Prisons, “such that the remaining residents can be housed safely and in compliance with CDC guidance at Hope Village.” Pls.’ Mot. TRO, ECF No. 3. On April 7, 2020, the Court held a telephone hearing concerning this motion. For the reasons stated on the record during the telephone hearing, Plaintiffs’ motion for a temporary restraining order (ECF No. 3) is **DENIED**. The Court requests further daily updates from each of the Defendants, as set forth below, and will hold a separate hearing concerning Plaintiffs’ motion for a preliminary injunction, ECF No. 4. It is hereby:

**ORDERED** that the Court takes under advisement Plaintiffs’ motion for a preliminary injunction and grants the parties leave to file any supplemental briefings by **Friday, April 10, 2020**; and it is

**FURTHER ORDERED** that Defendants shall submit under seal the following reports on the docket each day:

(1) Defendant Hope Village shall file a daily census of the overall population at the facility; the number of individuals who have been tested for COVID-19; the number of pending results, if any; and the number of confirmed positive or negative results; and

(2) Defendant Federal Bureau of Prisons shall file a daily notice with the number of home confinement requests for individuals at Hope Village that are pending as well as the number of said requests that it has granted; and it is

**FURTHER ORDERED** that Defendant Hope Village shall, by no later than Monday, April 13, 2020, submit a roster setting forth the following information for each Hope Village resident: (1) age; (2) any preexisting medical conditions; (3) time remaining on the sentence; (4) underlying offense for which the individual is held; (5) whether the individual has a home to which he might be released; (6) whether the individual is statutorily eligible for home confinement; and (7) any other information that might be helpful in considering the relevant issues; and it is

**FURTHER ORDERED** that the above-referenced daily notices and roster may be filed under seal, so long as the information is accessible to all parties, subject to a forthcoming protective order between the parties; and it is

**FURTHER ORDERED** that the parties shall appear for a telephone hearing on Plaintiffs' motion for a preliminary injunction on **Tuesday, April 14, 2020, at 11:00 AM**. Instructions on how to access the call will be emailed to counsel.
