Text of Order: On Friday, May 8, 2020, the court ordered counsel for both sides to propose additional conditions to the courts template bail order (a fillable PDF with numerous options for the court to impose depending on the individual detainee). Under the circumstances, the court permitted this to be submitted via email over the weekend to the courts case manager. Counsel for the petitioners communicated this afternoon that they had no additional suggestions. Rather than make suggestions to the template bail order via email, counsel for respondents raised a legal objection to a section of the courts bail order. The section of the bail order to which respondents object prohibits ICE from arresting a petitioner while on release in this case unless arrested on a warrant from a federal judge or pursuant to an order of removal to occur within 2 weeks. To be clear, the court put on the record during the first bail hearing in this case where the court released a petitioner that it intended to include this re-arrest condition in the courts bail order. The court explained to counsel that it was borrowing the re-arrest provision from Judge Youngs bail order in Savino. The court does not recall the government raising an objection at that time; indeed, the government raised objections for the first time on Friday, and now via an email on todays date.
