REPORT

Correctional Services Corporation has announced that it is not feasible for that company to continue operating Tallulah Correctional Center for Youth. The State has assumed operational control of the facility. Jerry W. Goodwin, Warden of Swanson Correctional Center for Youth, and other senior officers from Swanson Correctional Center for Youth have been temporarily assigned supervisory authority of TCCY.

Since the expiration of the October 4, 1998 Interim Agreement, the State has voluntarily continued to follow procedures in that agreement regarding such matters as Administrative Segregation and use of mechanical and chemical restraints. As the Department of Public Safety and Corrections regains control of TCCY, it may be necessary for the Department of Public Safety and Corrections to depart from some of the procedures established in that agreement - particularly in the
