Filed order (Appellate Commissioner): Pursuant to the April 8, 2014 case management conference, appeal numbers 13-50572, 13-50578, 13-50580, and 14-50051 are consolidated. The Clerk shall change the court's docket to so reflect. The district court's February 25, 2011 amended protective order (docket number 56) to prevent certain sensitive but unclassified discovery materials from being disclosed without limitation to persons not parties to the court proceedings in this matter, and the district court's September 17, 2012 protective order (document number 198) to prevent the unauthorized use, disclosure or dissemination of classified national security information and documents, shall continue in effect on appeal. See Section 3 of the Classified Information Procedures Act, 18 U.S.C. App. 3; Security Procedures Established Pursuant to Pub.
