

As to the Anderson County Prison Parm, on information furnished the undersigned by John T. Ashley, Anderson County Supervisor, there is now and has been for several months under construction a new brick complex which is scheduled for completion on or about the 25th day of June, 1970, which when completed will be of sufficient size to house all of the prisoners in one building as present facilities are not sufficient in size for all prisoners to be housed in one building. That the Prison Farm population as of May 22, 1970, is a total of eighty-nine (S9), of which sixty (60) are white and twenty-nine (29) are colored. In Camp Number One there are five (5) white and twenty-three (23) colored and in Camp Number Two there are fifty-five (55) white and six (6) colored.
