PLAINTIFFS' MOTION FOR DISQUALIFICATION

COMES NOW, Plaintiffs JOSIE MACHOVEC, CARL HOLME, KAREN HOLME, RACHEL EADE and ROBERT SPREITZER ("Plaintiffs/Movants"), by and through the undersigned, pursuant to Florida Statute § 38.10 and Rule 2.330 of the Florida Rules of Judicial Administration, hereby move to disqualify the Honorable John S. Kastrenakes from further proceedings in the above-captioned matter on the grounds that Plaintiffs reasonably fear they will not receive a fair trial or hearing and that the Judge before whom the case is pending is prejudice or biased. As grounds for this motion, Plaintiffs state as follows:

1. This is a case challenging the constitutionality of Palm Beach County's mask mandate [Order No. 2020-012] enacted June 25, 2020, which remains in effect purportedly due to a COVID-19 pandemic (hereinafter "Order"). The Order being challenged by Plaintiffs, both facially and asapplied, includes the following: "Facial coverings must be worn by all persons in public places where social distancing in accordance with CDC guidelines is not possible or not being practiced. For purposes of this provision, public places shall include any outdoor areas that are open...." The Order has been extended multiple times and remains in effect until December 21, 2020. See:

https://discover.pbcgov.org/PDF/COVID19/PBC-EO-30.pdf (stating "Executive Order2020-012 is hereby extended until 12:01 a.m. on December 21, 2020.").

- 2. On December 12, 2020, it was reported that the Honorable John S. Kastrenakes—the Judge before whom the above-captioned action is pending—recently attended an in-person holiday party in Palm Beach County, Florida and was not wearing a mask where social distancing was not possible or being practiced, in violation of the Order at issue in this case. *See*: "Judge John Kastrenakes, Presiding Over Mask Case, Unmasked At Palm Beach County Bar Association Party" by BocaNewsNow.com, published December 12, 2020, publicly-available online at https://bocanewsnow.com/2020/12/12/judge-john-kastrenakes-presiding-over-mask-case-unmasked-at-palm-beach-county-bar-association-party/ (stating, "Kastrenakes' appearance at the event regardless of mask use may lead to questions concerning his judgment by attorneys on both sides of the constitutional case. Why a judge presiding over a heated issue like masking would attend an in-person holiday party as the CDC says no holiday party is safe is a potential issue. His appearance without a mask at the party while in line at a buffet also raises questions about his beliefs when it comes to masking and social distancing.").
- 3. Attached as Composite Exhibit "A" are Plaintiffs' statements and sworn affidavits pursuant to Florida Statute § 38.10 stating Plaintiffs fear that they will not receive a fair trial or hearing because of the prejudice or bias of Judge John S. Kastrenakes.
- 4. Attached as Exhibit "B" is a photograph of the Honorable John S. Kastrenakes at the above-referenced event in Palm Beach County not wearing a mask over both nose and mouth while not practicing social distancing in accordance with the Order at issue in this case, or CDC guidelines.
- 5. As the trier of fact in the above-captioned action, Judge John S. Kastrenakes' conduct in publicly flaunting the Order at issue in the above-captioned action shows the Judge's undue bias, prejudice, or sympathy for other public officials and individuals who may be called as witnesses in

this action, including but not limited to members of the Palm Beach County Board of County Commissioners who have similarly not complied with the mask mandate and/or have selectively or discriminatorily enforced the Order at issue in this case.

6. Based on the above-referenced newly discovered facts, Plaintiffs reasonably fear they will not receive a fair trial or hearing because of the above-described prejudice or bias of Judge John S. Kastrenakes.

WHEREFORE, for the reasons stated above, Plaintiffs/Movants hereby respectfully request that this Court disqualify the Honorable John S. Kastrenakes from presiding over the remainder of the above-captioned action.
