HIS OFFICE ALLOWS, PREPARE THE NECESSARY FORMS TO EFFECTUATE THE
TRANSFER OF SAID FUNDS FROM THE REGISTRY OF THE COURT OF THE SOUTHERN
DISTRICT OF NEW YORK, TO THE REGISTRY OF THE COURT OF THE SOUTHERN
DISTRICT OF TEXAS, FOR THE PURPOSE OF PLACING SAID FUNDS IN THE COURT
REGISTRY INVESTMENT SYSTEM, INTEREST BEARING ACCOUNT; AND IT IS FURTHER

ORDERED THAT THE CLERK SHALL DEDUCT FROM THE INCOME EARNED ON
THE INVESTMENT A FEE NOT EXCEEDING THAT AUTHORIZED BY THE JUDICIAL
CONFERENCE OF THE UNITED STATES AND SET BY THE DIRECTOR OF THE
ADMINISTRATIVE OFFICE WHENEVER SUCH INCOME BECOMES AVAILABLE FOR
DEDUCTION FROM THE INVESTMENT SO HELD AND WITHOUT FURTHER ORDER OF
THIS COURT.

DEFENDANTS SHALL SERVE A SIGNED COPY OF THIS ORDER ON THE CLERK OF
THE COURT IN ROOM 18 AND ON A FINANCIAL DEPUTY IN THE CASHIER'S OFFICE.
