The plaintiffs in these actions having moved the Court for an order effectuating defendant compliance with the Court's Judgment of October 2, 1974, and the Court having determined that compliance with the Court's Judgment will be effectuated by notice of the Court's Judgment of October 2, 1974 to all members of the plaintiff class and the court having further determined that such notice is necessary for the protection of the members of the class, it is

ORDERED, that notice of the Court's Judgment be given to each person detained in the Brooklyn House of Detention and the Queens House of Detention by distributing a written copy of the following notice by hand to each detainee and by posting a copy in a plainly visible public place on each tier of the Brooklyn House of Detention and the Queens House of Detention on which detainees are housed:

NOTICE TO ALL PERSONS CONFINED IN THE BROOKLYN HOUSE OF DETENTION AND THE QUEENS HOUSE OF DETENTION

The United States District Court, Hon. Orrin G. Judd, has ordered that if you have been confined in this institution for more than thirty days, the Department of Correction may not confine you in a cell with another person unless both of you voluntarily consent, in writing, to being double-celled, and the confined with a property and the confined with a property and the confined with a property and the confined with a point the confined with the confin

If you choose to live in a cell by yourself, the Department cannot make you share a cell with another inmate in this or any other institution.

If, after thirty days of incarcefation, you wish to remain double called, you should inform the warden in writing by sanding him an interview slip.

If you wish to write to the attorneys for the detainees in these cases concerning this order, address your letter to Michael B. Mushlin or Steven A. Herman, Esq., Prisoners' Rights Project, Legal Aid Society, 15 Park Row, New York, New York 10038

This notice must remain where it is posted. Do not remove it; and it is further,

ORDERED, that the Legal Aid Society reproduce the necessary copies of the above notice and deliver them to the Warden of the Brooklyn House of Detention and to the Warden of the Queens House of Detention for distribution; and it is further

ORDERED, that the Warden of the Brooklyn House of Detention, and the Warden of the Queens House of Detention shall cause a copy of the above notice to be distributed by hand, to each detainee presently in the institution and to other detainees upon admittance to the institution, and to be posted in a plainly visible public place on each tier in which detainees are housed in the above institutions, and it is further

ORDERED, that defendants shall notify plaintiffs' counsel in writing when said distribution of the notice to plaintiff class is completed.
