PLAINTIFF EEOC'S MOTION TO MODIFY CONSENT DECREE

Comes now Plaintiff Equal Employment Opportunity Commission and moves this Court to modify the consent decree entered in this action by adding Marquis D. Avant and Calvin L. Nelson as additional aggrieved parties identified on Attachment A to the Consent Decree. Attached hereto is a modified Attachment A which includes Marquis D. Avant and Calvin L. Nelson. In support of its motion Plaintiff EEOC states:

1. After the parties submitted the proposed consent decree to the court, Plaintiff EEOC was contacted by Marquis D. Avant and Calvin L. Nelson, each of whom claimed that he was an African American who had been hired as a part-time dock docker and passed over for a full-time dock worker position by a less senior Caucasian part-time dock worker.

2. Plaintiff EEOC was able to verify from the records provided by FedEx Freight, Inc., that Nelson was an African-American, that he had been passed over for full time employment by a less senior Caucasian part-time dockworker six (6) days before Nelson's employment ended. Accordingly, he should be entitled to a proportionate share of the relief to be provided to the additional aggrieved parties as provided by Paragraph II. C of the Consent Decree.

3. Plaintiff EEOC believes based upon information provided by Marquis Avant that he was hired as a part-time dock worker in February 1998 and became full-time on June 28, 1998, and that Warren W. Beem, Joseph J. Dunn and Shaun W. Shaffer, are Caucasians and that each was hired part-time after Avant and became full time before him. Records provided by FedEx Freight East, Inc., show that Beem, Dunn, and Shaffer are Caucasians and that each became full-time dock workers on June 1, 1998, and that Avant became a full-time dockworker on June 28, 1998. Defendant's records do not reflect part-time employment for Beem, Dunn, Shaffer, or Avant. Plaintiff has provided the assertions of Avant to Defendant FedEx Freight East, Inc., for verification and it does not dispute Avant's claim. Defendant's records also show that Avant is an African-American. Accordingly, Plaintiff EEOC believes Avant should be entitled to a proportionate share of the relief to be provided to the additional aggrieved parties as provided by Paragraph II. C of the Consent Decree.

4. No other provision of the Consent Decree needs to be modified.

5. Defendant and the Plaintiff-Intervenors do not oppose this motion.

WHEREFORE for good cause shown, the Plaintiff respectfully requests the Court to modify the consent decree entered in this action by adding Marquis D. Avant and Calvin L. Nelson as additional aggrieved parties.
