In support of this motion, movants state:

1. The order of this Court entered in this cause on May 18, 1979, provides, among other things, "No new construction of elderly units shall commence until a proportionate amount (400 GPHA family units/886 elderly units) of new construction and rehabilitation of family units in the General Public Housing Area has commenced . . ." (¶1(c), Order of May 18, 1979.) The order of this Court entered in this cause on August 14, 1987, defines the "scattered site program" to include "all CHA non-elderly public housing development programs which may in the future be authorized by HUD during the pendency of Civil Action No. 66C1459." (Page 2, Order of August 14, 1987.)

- 2. Notwithstanding said provisions of said orders referred to in paragraph 1 hereof, movants agree that it is in the interest of the plaintiff class to permit the Receiver to develop cluster housing for not more than 100 elderly units, utilizing CHA reservations for elderly units from CHA Development Programs 2-99 and 2-101, provided that both the family and elderly components, respectively, of individual cluster developments be limited to no more than 50 units.
- 3. Movants represent to the Court that they believe that the Defendant, UNITED STATES DEPARTMENT OF HOUSING & URBAN DEVELOPMENT, has no objection to this motion.

Accordingly, movants ask the Court to enter an agreed order in the form attached hereto.


