ORDER

On October 21, 1982, this Court entered an Order which, inter alia, required defendants to submit evidence of compliance with the procedural due process portions of the Court's June 21, 1982 Opinion and Order. The evidence of compliance was to be submitted by November 22, 1982.

On November 22, 1982, defendants filed a paper labelled "Notice of Compliance." The paper contains representations by Assistant Attorney General MacKenzie indicating that defendants have implemented the procedural due process portions of the Court's June 21, 1982 Opinion and Order.


The November 22, 1982 paper will not do. The Court requires evidence of compliance. Such evidence must be in the form of sworn statements by the Wardens of State Prison of Southern Michigan, the Michigan Reformatory at Ionia and Marquette Branch Prisons. These statements must demonstrate to the Court that the procedural due process portions of the June 21, 1982 Opinion and Order are being adhered to.

The Court will give defendants fifteen (15) days from the date of this Order to file the said evidence of compliance. The Court would also point out that defendants are trying the Court's patience. It simply is not reasonable for defendants to delay implementing the constitutional procedural due process requirements set out in the June 21, 1982 Opinion and Order. The Court warns that if defendants do not

comply with this Order, the Court will promptly set a hearing date on the issue of whether defendants should be held in contempt of court.


