ORDER GRANTING PLAINTIFFS' MOTION FOR SUMMARY JUDGMENT AND DENYING DEFENDANTS' CROSS-MOTION FOR SUMMARY JUDGMENT

Plaintiffs' Motion for a Summary Judgment comes on for hearing on January 23, 2014. The Plaintiffs appeared by David Brown, Tiseme Zegeye, Martha M. Hardwick, and Anne Zachritz. All Defendants, represented by the office of Attorney General E. Scott Pruitt, appeared by Patrick R. Wyrick, Solicitor General, and Cara N. Rodriguez, Assistant Solicitor General. After reviewing Plaintiffs' Motion for Summary Judgment, Plaintiffs' Memorandum of Law in Support of their Motion for Summary Judgment and Defendants' Response in Opposition to Plaintiffs' Motion for Summary Judgment and Defendants' Cross-Motion for Summary Judgment, Defendants' Memorandum of Law in Support of their Response in Opposition to Plaintiffs' Motion for Summary Judgment and Defendants' Cross-Motion for Summary Judgment, Plaintiffs' Memorandum of Law in Opposition to Defendants' Cross-Motion for Summary Judgment and in Further Support of Plaintiffs' Motion for Summary Judgment, and Defendants' Reply to Plaintiffs' Memorandum of Law in Opposition to Defendants' Cross-Motion for Summary Judgment, and Defendants' Reply to Plaintiffs'

Judgment, and having heard oral argument, the Court hereby GRANTS Plaintiffs' motion and DENIES Defendants' motion.

Plaintiffs have demonstrated that there are no material facts in dispute and House Bill 2226, codified at OKLA. STAT. tit. 59, § 369 and OKLA. STAT. tit. 63, § 313A, violates the single subject rule of Article V Section 57 of the Oklahoma Constitution. Therefore,

IT IS HEREBY ORDERED:

- House Bill 2226, codified at OKLA. STAT. tit. 59, § 369 and OKLA. STAT. tit.
 63, § 313A, is declared unconstitutional and is void and of no effect.
- 2. The Defendants, their employees, agents, and successors in office are hereby permanently enjoined from enforcing the provisions of House Bill 2226.
