**TEMPORARY RESTRAINING ORDER AND
SCHEDULING ORDER**

The Parties' Joint Motion for Scheduling Order and for Order Approving Agreed Temporary Restraining Order is now before the Court for consideration. In accordance with Rule 4(h) of the Rules for District Courts, the Court finds that a hearing would not materially assist the Court in ruling on the Motion which is jointly presented by all Parties. After reviewing the Motion and Brief in Support, the Court finds that the Motion is supported by good cause and that the same should be granted.


IT IS THEREFORE ORDERED THAT:

1. A temporary restraining order enjoining enforcement of House Bill 2780 pending determination of Plaintiffs' motion for a temporary injunction is granted, effective immediately; thus, Defendants, their employees, agents, and successors in office are hereby enjoined from enforcing House Bill 2780 until such time as the Court holds a hearing and issues a final disposition on Plaintiffs' motion for a temporary injunction.
2. Defendants' deadline to respond to Plaintiffs' Petition will be extended until June 14, 2010.
3. Defendants' deadline to respond to Plaintiffs' Motion for a Temporary Injunction will be extended until June 14, 2010.
4. Plaintiffs will reply to Defendants' Response to the Motion for a Temporary Injunction no later than five (5) days before the hearing on Plaintiffs' Motion for a Temporary Injunction.
5. The Court shall hold a hearing on Plaintiffs' motion for a temporary injunction on Monday July 19 @ 9:00am, 2010.






