**ORDER CONFIRMING UNDISPUTED
DIVISION OF ADULT PAROLE
OPERATIONS ATTORNEY'S FEES
AND COSTS FOR THE THIRD
QUARTER OF 2009**

1 On March 26, 1997, the District Court established procedures by which Plaintiffs are to
2 collect periodic attorneys' fees and costs in this case in connection with their work monitoring
3 Defendants' compliance with the Court's Orders and collecting fees.

4 Pursuant to these procedures, Plaintiffs served by overnight delivery their Third
5 Quarterly Statement for 2009 on Defendants on November 18, 2009. Defendants responded on
6 December 24, 2009. The parties completed their meet-and-confer process on January 26,
7 2010.

8 As a result of the January 26, 2010 agreement, the parties are able to agree to a
9 settlement of \$38,466.73 for fees and costs incurred during the Third Quarter of 2009, for
10 monitoring and fee collection activities in the Division of Adult Parole Operations portion of
11 the case. Attached hereto as Exhibit A is a chart setting forth the fees and costs claimed by
12 Plaintiffs for the Third Quarter of 2009, and the amounts agreed to by the parties to settle these
13 claims.

14 IT IS HEREBY ORDERED that \$38,466.73 is due and collectable as of forty-five days
15 from the date of entry of this Order. Interest on these fees and costs will run from December
16 19, 2009, accruing at the rate provided by 28 U.S.C. § 1961.
