Plaintiffs and Defendant have jointly requested that the Preliminary Injunction Hearing set for Thursday, May 11, 2023 at 1:00 p.m. be continued to Thursday, July 20, 2023, at 1:30 p.m. The parties also agreed in accordance with Rule 92.02(c)(2) that the temporary injunctive relief provided by the May 1, 2023 Court Order granting Plaintiffs Motion for a Temporary Restraining Order, which is set to expire four days after the currently scheduled hearing, should extend and continue to be in effect until four days after the new hearing, July 24, 2023, or until this Court rules on the Motion for Preliminary Injunction. It is SO ORDERED. By agreement of the parties and order of this Court, the Temporary Restraining Order entered on May 1, 2023, shall continue to remain in effect until July 24, 2023, or until this Court rules on the Motion for Preliminary Injunction. As such, Defendant, and all of their agents, servants, representatives, employees, attorneys, and those persons in active concert or participation with them, continue to be temporarily restrained and prohibited from, directly or indirectly implementing, enforcing, or applying any provision of the Missouri Attorney General's recent emergency rule, codified at 15 CSR 60-17.010 and titled, Experimental Interventions to Treat Gender Dysphoria.
