Amanda Henry is awarded as against Defendants Steven Alan Ehresman and Shari Louise Ehresman, husband and wife, and each of them, the principal sum of Two Hundred Fifty Thousand Dollars (\$250,000), which sum shall bear interest at the rate of 4.93% (as authorized pursuant to 28 U.S.C. § 1961(a)) from the date of this Judgment's entry until paid in full.
- 3. Tiara M. Brazle is awarded as against Defendants Steven Alan Ehresman and Shari Louise Ehresman, husband and wife, and each of them, the principal sum of Two Hundred Fifty Thousand Dollars (\$250,000), which sum shall bear interest at the rate of 4.93% (as authorized pursuant to 28 U.S.C. § 1961(a)) from the date of this Judgment's entry until paid in full.
- 4. Tamara A. Grubbs is awarded as against Defendants Steven Alan Ehresman and Shari Louise Ehresman, husband and wife, and each of them, the principal sum of Two Hundred Fifty Thousand Dollars (\$250,000), which sum shall
