1. I am over the age of 18, make this declaration from my personal knowledge and, if called upon to do so, could and would competently testify to the matters set forth herein in a court of law.

2. I am a proposed intervenor-defendant in the case *Hoge v. Padilla*, No. 2:19-cv-01985.

3. I am twenty-two years old and reside in California.

4. I am currently an undergraduate at the University of California, Los Angeles.

5. I was born in Oaxaca, Mexico and moved to San Diego, California during the first grade.

6. I became a naturalized citizen of the United States on June 20, 2018.

7. My naturalization documents are in my family's possession in San Diego County, California.

8. On October 19, 2017, before becoming a naturalized citizen, I applied for and received a California identification card at the California Department of Motor Vehicles.

9. Although I am eligible to vote, I am not registered to vote.


10. I do not have a California driver's license.
