- B. Within 21 days of receipt of the complaint form, the Monitor shall conduct an investigation of the complaint, make an initial recommendation, and serve it on Prison Legal Services of Michigan, Inc., and A. Peter Govorchin, Assistant Attorney General.
- 3. Paragraph II.C. shall be amended to read as follows:
- C. Objections to the initial recommendation, if any, shall be served on the other party and the Monitor within ten days of receipt by the objecting party of the initial recommendation.
- 4. Notwithstanding any other order of this Court, the *Cain* Monitor's duties and authority under any orders of this Court shall terminate effective February 1, 2004.
- 5. Prison Legal Services of Michigan, Inc. (PLSM) may prepare and file with the Monitor complaints alleging noncompliance with an order of this Court if the complaint of noncompliance is received from the prisoner class member by PLSM no later than November 1,
