ANDREWS: IN LIEU OF A HEARING ON THE SPECIALLY SCHEDULED MOTION DOCKET OF THURSDAY, JUNE 11, 2020, AT 10:00 A.M., THE COURT SHALL, UPON AGREEMENT OF THE PARTIES, RULE ON THE BRIEF(S) SUBMITTED BY THE PARTIES HERETO PURSUANT TO RULE 4(H) OF THE RULES FOR THE DISTRICT COURTS OF OKLAHOMA. THE COURT, HAVING REVIEWED PLAINTIFFS' MOTION FOR PROTECTIVE ORDER FILED ON MAY 15, 2020, DEFENDANTS' RESPONSE IN PARTIAL OPPOSITION TO PLAINTIFFS' MOTION FOR A PROTECTIVE ORDER FILED ON JUNE 1, 2020, AND PLAINTIFFS' REPLY IN SUPPORT OF MOTION FOR PROTECTIVE ORDER FILED ON JUNE 4, 2020, FINDS AND ORDERS AS FOLLOWS:

1. THE OKLAHOMA OPEN RECORDS ACT REQUIRES THAT THE COURT MUST MAKE A SPECIFIC DETERMINATION THAT IT IS IN THE "INTEREST OF JUSTICE" TO SEAL MATERIALS FROM THE PUBLIC WITH THE "[S]PECIFIC IDENTIFICATION OF THE MATERIAL WHICH IS TO BE WITHHELD." 51 O.S. §24A.29(A)(2).

2. THE PORTIONS OF PLAINTIFFS' PROPOSED PROTECTIVE ORDER THAT DEFENDANTS DO NOT DISPUTE ARE APPROVED BY THE COURT AND SHALL BE DEEMED "CONFIDENTIAL INFORMATION", INCLUDING:

A. THE NAMES AND PERSONAL IDENTIFYING INFORMATION OF PHYSICIANS, STAFF MEMBERS AND PATIENTS NOT ALREADY MADE PUBLIC IN THIS CASE;

B. THE IDENTIFICATION OF "PERSONS AFFILIATED" WITH THE PARTIES; AND

C. REPORTS EXEMPT FROM THE OKLAHOMA OPEN RECORDS ACT.

3. PARAGRAPHS #2-18 OF PLAINTIFFS' PROPOSED PROTECTIVE ORDER, WHICH DEFENDANTS ALSO DO NOT DISPUTE, ARE APPROVED BY THE COURT.

4. ANY INFORMATION THAT IS OR HAS BEEN IN THE PUBLIC DOMAIN IS NOT COVERED BY THIS PROTECTIVE ORDER.

5. PARAGRAPH #1 OF DEFENDANTS' PROPOSED PROTECTIVE ORDER IS APPROVED BY THE COURT; THAT PLAINTIFFS HAVE THE ABILITY TO SEEK A PROTECTIVE ORDER DETERMINING WHETHER ANY OF THEIR MATERIALS, DOCUMENTS OR RECORDS THAT THEY ASSERT ARE PRIVATE, PROPRIETARY COMMERCIALY SENSITIVE BUSINESS PAPERS OR ALL POLICIES AND PROCEDURES SHOULD BE SEALED FROM THE PUBLIC "IN THE INTEREST OF JUSTICE". 51 O.S. §24A.29. IF THIS SHOULD OCCUR, THEN THE MATERIALS, DOCUMENTS OR RECORDS MUST BE SUBMITTED FOR AN IN CAMERA REVIEW BY THE COURT BEFORE ANY RULING CAN BE MADE. THIS DOES PREVENT THE PARTIES FROM SUBMITTING AN AGREED ORDER TO THE COURT STIPULATING TO THE CONFIDENTIAL NATURE OF THE MATERIALS, DOCUMENTS OR RECORDS AND REQUESTING THAT THEY SHOULD BE SEALED FROM THE PUBLIC "IN THE INTEREST OF JUSTICE".

6. REGARDING SUBPOENAS ISSUED BY DEFENDANTS TO NON-PARTIES, THE COURT MAY, LIKEWISE, ISSUE "ANY [PROTECTIVE] ORDER WHICH JUSTICE REQUIRES" "[U]PON MOTION BY A PARTY OR BY THE PERSON FROM WHOM DISCOVERY IS SOUGHT." 12 O.S. §3226)(C)(1).

7. THE FOLLOWING PARAGRAPH SHALL BE ADDED TO THE COURT'S PROTECTIVE ORDER:

PURSUANT TO THE OKLAHOMA OPEN RECORDS ACT (51 O.S. §24.A1, ET.SEQ.), A FULL HEARING IS REQUIRED TO DETERMINE WHETHER PUBLIC RECORDS SHOULD BE SEALED, WITH THE COURT MAKING SPECIFIC FINDINGS THAT THE SEALING OF PUBLIC RECORDS IS NECESSARY IN THE INTEREST OF JUSTICE.

ACCORDINGLY, PLAINTIFFS' MOTION FOR PROTECTIVE ORDER IS SUSTAINED IN-PART AND OVERRULED IN-PART. COUNSEL FOR PLAINTIFF IS DIRECTED TO PREPARE AN ORDER CONSISTENT WITH THE COURT'S RULING, CIRCULATE THE SAME FOR SIGNATURES, AND PRESENT IT TO THE COURT FOR ENTRY.
