The Court has before it Plaintiff-Intervenor Jennifer Crick's Motion to Intervene (Docket No. 4) and a Stipulated Motion to Intervene and to File Complaint in Intervention (Docket No. 12). Ms. Crick filed her Motion to Intervene on October 29, 2001. On December 7, 2001, Ms. Crick and the parties to the above-entitled lawsuit filed the Stipulated Motion to Intervene requesting the following: (1) that Ms. Crick be allowed to intervene in the lawsuit; (2) that the Court exercise supplemental jurisdiction over her state law claims against Sinclair Oil Corporation, Sun Valley Company, and Mike and Amy Federko; and (3) that the Court permit Ms. Crick to file and serve her Complaint pursuant to Federal Rule of Civil Procedure 24(a) and 28 U.S.C. § 1367.

The Court has considered the Motion to Intervene and the Complaint attached as Exhibit "A" thereto, and has recognized that the parties have stipulated to the Motion. As a result, the Court finds: (1) Ms. Crick has a right to intervene in this matter; (2) this Court has supplemental jurisdiction over Ms. Crick's state law claims; and (3) Ms. Crick is entitled to serve and file her

Complaint. Accordingly,

NOW THEREFORE IT IS HEREBY ORDERED, that Plaintiff-Intervenor's Motion to Intervene (Docket No. 4) shall be, and the same is hereby, deemed MOOT.

IT IS FURTHER ORDERED, that the Stipulated Motion to Intervene and to File Complaint in Intervention (Docket No. 12) shall be, and the same is hereby, GRANTED.

IT IS FURTHER ORDERED, that Ms. Crick shall be allowed to intervene in the aboveentitled matter.

IT IS FURTHER ORDERED, that this Court shall exercise supplemental jurisdiction over Ms. Crick's state law claims.

IT IS FURTHER ORDERED, that Ms. Crick shall be allowed to serve and file her Complaint, which is attached to the Stipulated Motion to Intervene as Exhibit "A".
