PASSAIC COUNTY BOARD OF FREEHOLDERS, AND MARTIN BARNES, DIRECTOR OF THE PASSAIC COUNTY YOUTH CENTER

This matter having come before the Court for a hearing on November 20, 1978, on motion of William J. Bizub, Esq., First Assistant Deputy Public Defender, appearing on behalf of plaintiff, P.H. et al, and Elaine W. Ballai, Esq., Deputy Attorney General, appearing on behalf of the New Jersey Department of Corrections, and Leo Gellene, Esq., appearing on behalf of defendants,

Passaic County Board of Freeholders and Martin Barnes, and Burrell Ives
Humphreys, Esq., Passaic County Prosecutor, appearing as Amicus Curiae,
and the Court having heard the testimony of Joseph DeJames, Director,
Juvenile Detention and Monitoring Unit, Department of Corrections as to
conditions and inspections conducted at the Juvenile Detention facility and
Wing Unit at Preakness Hospital, and having heard testimony from defendants'
witness Martin Barnes, Superintendent of the Juvenile Detention facility, and
the Court having determined from the testimony and its review of the entire
record in this matter that:

- 1. Numerous violations of the Department of Corrections Standards both physical and programatic, exist at both the Juvenile Detention facility and Preakness Wing;
- 2. The present facilities are inadequate to meet the needs of the juveniles confined therein and to meet requirements of law and public safety, and are not in accordance with N.J.S.A. 2A:4-42b;
 - 3. The present facilities are overcrowded;
- 4. The present facilities present a hazard to the well-being of the juveniles confined therein;
- 5. Additional discretionary space (recreation, classroom, indoor, outdoor) is needed immediately to satisfy requirements of law;
- 6. There has been unnecessary and unjustifiable delay on the part of the Board of Freeholders in correcting these undesirable conditions;

THEREFORE, IT IS on this
1978. ORDERED that:

- 1. The use of the Passaic County Detention Center at Wayne, New Jersey, is permitted on a temporary basis only, such temporary use being subject to the provisions hereinafter contained.
- 2. Defendants shall begin immediately to abate present violations at both the main structure and the Preakness Wing all as set forth on attached Schedules A, B, C and D, said abatement of violations to be completed no later than sixty days from the date of this Order.
- 3. A representative of the Board of Freeholders shall meet with and consult with representatives of the Department of Corrections twice a month for upon application to the Court by any party more than twice a month. The dates and time to be determined by the parties. Said meeting is to enable the Freeholder representative to advise the Department of any progress and the Department to advise the Freeholder representative what remains to be accomplished to abate violations.
- 4. Defendants shall, within fifteen days of this Order, provide the Court and the Department of Corrections with a written schedule under which abatement of violations shall be accomplished and on or before February 15, 1979, a list of those items completed together with schedule for completion of abatement of remaining items.
- 5. Defendants shall within fifteen days, supply the Court and the Department of Corrections with the name or names of the persons employed

at the Juvenile Vetention facility primarily responsible on an ongoing basis, who actually perform the janitorial duties so as to meet Department of Corrections Standards and applicable law regarding sanitation on a continuing basis. No juvenile shall be used as a substitute for staff.

- 6. Within thirty days the Board of Freeholders and Martin Barnes are to provide specifications and plans to the Court and Department of Corrections for the procurement and installation of a modular unit, similar in type and size to the present unit used for a lounge and classroom, for additional classroom and recreation space. The modular unit shall be subject to approval by the State Department of Corrections and the appropriate official of the Township of Wayne. Within sixty days after such approvals, the aforementioned modular unit shall be installed and completed.
- 7. All rooms, including reception rooms, hallways and stairways shall be adequately lighted. Power and lighting systems shall be installed and maintained in conformity with the New Jersey Uniform Construction Code and related national standards for efficient design and safety. Such systems shall include emergency light and power necessary and critical for safety, (particularly fire protection, equipment operation and exit illumination), security and minimum program continuity.
- 8. Defendants, Passaic County Board of Freeholders and Martin Barnes, shall take the necessary steps forthwith, to provide for the long-range needs of juveniles confined at the juvenile detention facility pursuant to N.J.S.A. 2A:4-42b, either by the construction of a new and larger facility

approved by the Department of Corrections or by expansion of existing structures in conformity with applicable state law, local building codes and Department of Corrections Standards for same. All plans for said facility shall be submitted promptly to the Department of Corrections for prior approval and to the Presiding Judge of the Passaic County Juvenile and Domestic Relations Court for review and recommendations.

- 9. Within ninety days from this Order, defendants shall submit final architectural and financial plans to this Court and the Department of Corrections together with schedule of construction.
- 10. Thereafter, on the first day of every month, defendants shall notify the Court and the Department of Corrections in writing as to the progres. made on said construction work. After abatement of all violations, the parties herein will meet once a month (or upon application to the Court by any party more than once a month). The dates and time shall be determined by the parties Said meeting is to enable the representative and the Department of Corrections to consult on progress (or lack of it) of the new construction.
- 11. The defendants may continue to use the Passaic County Juvenila Detention facility as a facility for juveniles detained on juvenile delinquence complaints on a temporary basis pending the construction cited above, but shall comply with requirements of N.J.S.A. 2A:4-42b and the standards set forth by the Department of Corrections and on condition that the heating problem is solved by a temporary measure approved by local fire, health and building code

and in cooperation with the Department of Corrections and subject to the Department of Corrections' approval.

- 12. Prior to the expansion of existing facilities or construction of new facilities, the defendants shall not house more than the number of boys and girls approved by the Department of Corrections. However, if the Prosecutor of Passaic County deems said number of allowable population inadequate to meet the needs of public safety, the Prosecutor shall apply to the Court, on three days notice to the Department of Corrections, for permission to increase the number of juvenile detainees on a temporary basis. Pending the hearing on said application, the number may exceed the number approved by the Department of Corrections.
- 13. Within fourteen days defendants shall provide information to the State Department of Corrections regarding how the needs of the juveniles housed at the second floor of the Preakness Hospital Unit will be met. The information provided shall be in accordance with the outline for Juvenile Detention facility plans (forwarded to Martin Barnes, Director, dated September 11, 1978) and shall provide adequate provisions to the satisfaction of the State Department of Corrections for the needs established therein, except that Section 1, Needs Assessment, need not be addressed. See Schedule D attached to this Order.
- 14. The Manual of Standards for Juvenile Detention Facilities authored by the State of New Jersey, Department of Corrections, shall be

complied with by the Board of Freeholders and Martin Barnes, Director of the Passaic County Juvenile Detention facility, and his staff trained in accordance with the provisions therein.

15. No juvenile shall be housed in any quarters which do not maintain a minimum temperature of 68 degrees F. during the day, 65 degrees F. during the night.

This Court shall retain jurisdiction of this matter to insure compliance with all terms of this Order.

PASSAIC COUNTY PROPOSED TEMPORARY JUVENILE DETENTION FACILITY PRELIMINARY PHYSICAL FACILITY INSPECTION REPORT

The following is a report of physical facility problems which were noted during a preliminary inspection tour on August 24, 1978 of the Passaic County Jail Work Release building, second floor front. Pursuant to N.J.S.A. 2A:4-57, the premises were inspected for possible use as a temporary juvenile detention facility. It is recommended that no renovation work commence until a final decision regarding the viability of the proposed program is made by this office. A comprehensive description of the proposed program has been requested in previous correspondence. Once this information is received, a decision will be made and the County will be so notified.

A. General Information

- 1. Sleeping Rooms:
 Thirteen (13) rooms were inspected for use as sleeping rooms. Each room contains approximately 72 sq. ft. of space. The Manual Of Standards For Juvenile Detention Facilities requires 80 sq. ft.; however, a variance would be granted to permit one (1) juvenile per room if the program is approved. A maximum population capacity will be assigned at that time.
- Toilet Facilities:
 Two (2) commodes- Three (3) urinals-Three (3) basins
 Two (2) showers- One (1) bathtub
 Note: Present toilet facilities are sufficient for
 twelve (12) juveniles.
- 3. Other Rooms:
 Storage room (#505)- 72 sq. ft.
 Supervisor's Office (#501)- 72 sq. ft.
 Day room- 198 sq. ft.

B. Physical Violations

- 1. The facility is infested with roaches and must be professionally exterminated.
- 2. All torn or otherwise damaged window screens shall be repaired or replaced as necessary.
- 3. All cracked or broken window panes shall be replaced.
- 4. All window frames with cracked and peeling paint shall be scraped and repainted.
- 5. All beds shall be securely anchored to the floor.
- 6. All beds shall be equipped with comfortable, fire and water resistant mattresses.

B. Physical Violations (cont'd)

- 7. All closets shall either be repaired to operate properly or kept locked. Room number 510 has an electrical circuit breaker panel in the closet which must be adequately protected from tampering.
- 8. All radiators and covers shall be cleaned.
- 9. All loose, missing, or broken floor tiles shall be replaced.
- 10. Locate and repair the source of all water leaks. Scrape and repaint damaged areas.
- 11. All electrical outlets shall be securely covered using tamperproof hardware.
- 12. All electric lighting fixtures shall be completely enclosed with tamperproof hardware and safety glass or heavy translucent plastic.
- 13. All standard electric light switches shall be replaced with tamperproof security type switches.
- 14. An inspection by an agency certified by the New Jersey Public Utilities Commission shall be conducted of all electrical work to ensure compliance with standard electrical codes. A copy of their report shall be submitted to this office.
- 15. All locks shall be checked and repaired as necessary.
- 16. All glass mirrors shall be replaced with unoreakable security mirrors.
- 17. The entire bathroom area shall be thoroughly cleaned and disinfected. Clean the grout and tiles in the shower stalls.
- 18. All defective or missing shower heads shall be repaired or replaced as necessary.
- 19. All defective water control handles shall be repaired or replaced as necessary.
- 20. All leaking or otherwise defective commodes and urinals shall be repaired.
- 21. Repair all holes in the walls.
- 22. Scrape and re-paint room divider around the tub.

- 23. Repair the water fountain.
- 24. Install a lock on closet door in the bathroom.
- 25. Replace shower curtains.
- 26. Provide adequate furnishings and equipment for the operation of a juvenile detention program.
- 27. Remove pipes and/or other objects from the fire escape area outside.
- 28. Replace or remove all defective window shades.
- 29. An appropriate number of portable fire extinguishers and smoke or thermal alarms shall be provided. An inspection shall be conducted by the local fire marshall and a copy of his report shall be forwarded to this office.
- 30. A graded, properly drained and enclosed outdoor recreation area shall be provided which is adequate in size for the population to be served.

SCHEDULE C

MAJOR PROGRAM VIOLATIONS

- 1. The facility lacks adequate fire safety procedures. The following provisions shall be implemented immediately:
 - (a) Emergency evacuation drills shall be conducted at least once a month, at varying times of the day and evening, and a separate log shall be kept which records the date, time of day and the length of time required to evacuate the building;
 - (b) All staff shall receive training at least once each year in the use of fire alarms, fire equipment and emergency evacuation techniques and procedures. A record of such training shall be maintained.
 - (c) Emergency evacuation procedures and diagrams indicating the location of all exits shall be prominently posted throughout the building. This information shall be explained to all staff and to each juvenile upon admission.
- 2. Comprehensive admission policies and procedures shall be immediately developed and implemented which provide for the following:
 - (a) Thorough search and shower procedures;
 - (b) Intake interview to secure necessary information regarding the juvenile, relieve undue emotional stress and explain the nature of the detention facility and programe in accordance with the requirements of Section V of the M.J. Department of Corrections' Manual of Standards for Juvenile Detention Facility.
- 3. The facility shall immediately develop and implement policies and procedures for the provision of emergency psychological or psychiatric care for the following types of crisis situations:
 - (a) Severe mental disturbance at time of admission, and;
 - (b) Severe behavorial aberrations such as attempted suicide, refusal to eat for extended periods of time, etc.
- 4. The facility shall immediately develop and implement policies and procedures for the use of room confinement which provides for the following:

- (a) Discontinuance of routine room confinement pending medical examination;
- (b) Development of written rules, regulations and sanctions regarding the use of room confinement as a disciplinary measure;
- (c) Development of written alternative sanctions to be used in lieu of room confinement;
- (d) Discontinuance of the routine practice of confining juveniles to their rooms for periods of twenty-four (24) to forty-eight (48) hours or more at a time. Room confinement should rarely be required for periods in excess of two (2) hours and should only be continued if the behavior which warranted isolation continues beyond that time.
- 5. The facility shall immediately provide an adequate number of staff to maintain the facility in a clean, healthy manner. A written maintenance schedule shall be developed which provides for regular cleaning of all areas of the facility. Juveniles shall not be used as substitutes for maintenance staff.
- 6. The facility lacks adequate education programming. The following provisions shall be implemented immediately:
 - (a) Two (2) additional full time teachers shall be hired immediately for a total of three (3) full time teachers assigned and teaching at the Passaic County Juvenile Detention facility.
 - (b) All other standards regarding education as cited in the <u>Manual of Standards</u> shall be implemented immediately.
