STIPULATED FINAL JUDGMENT

1 WHEREAS, all parties remaining in this case, namely Plaintiff Coalition on Homelessness
2 (“Coalition”) and Defendants City and County of San Francisco (“City”), San Francisco Police
3 Department (“SFPD”), San Francisco Department of Public Works (“DPW”), San Francisco
4 Department of Homelessness and Supportive Housing (“HSH”), San Francisco Fire Department
5 (“SFFD”), and San Francisco Department of Emergency Management (“DEM”) (together,
6 “Defendants” or the “City,” and together with Plaintiffs, “Parties”), have entered into and finally
7 approved a Settlement Agreement (“Agreement”), which is attached hereto as Exhibit 1; and

8 WHEREAS the Agreement provides, *inter alia*, that upon final approval of the Agreement, the
9 Parties will dismiss with prejudice all pending claims in this Court, and withdraw all pending appeals
10 in the U.S. Ninth Circuit Court of Appeals, that the Agreement will be entered as a Stipulated
11 Judgment of this Court, and that this Court shall retain jurisdiction to enforce the Agreement;

12 NOW THEREFORE, it is hereby ORDERED, ADJUDGED, and DECREED as follows:

- 13 1. The Agreement is entered as the Judgment of this Court.
- 14 2. The Court shall retain jurisdiction to enforce the Agreement pursuant to its terms.
- 15 3. Judgment is hereby entered dismissing the claims of Plaintiff Coalition on Homelessness
16 with prejudice.
