ORDER

This matter is before the Court on a Consent Decree (Doc. #29) submitted by the parties for the Court's approval. After reviewing the Consent Decree, the Court declines to approve it for the following reasons:

- 1. The Court finds no reason for it to retain jurisdiction to enforce the settlement between the parties, and declines to do so.
- 2. Footnote 1 appears to be incomplete, and paragraph 9 appears to have material missing.



3. Paragraphs 7 and 8 merely restate the law, and the Court declines to issue an injunction and retain jurisdiction to enforce an injunction which merely compels a party to obey the law.

Accordingly, it is now

ORDERED:

The Consent Decree (Doc. #29) is not approved by the Court. The parties may of course resolve the case with the settlement set forth in the Consent Decree without the Court's retention of jurisdiction.

Unless the Court is notified that the case has been settled, the case shall remain on the Court's calendar for the events and dates previously scheduled.
