

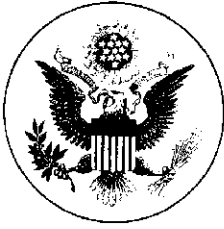
ORDER OF DISMISSAL
