FINAL JUDGMENT ORDER ENTERING CONSENT DECREE

On this day came on to be heard the Plaintiff's Motion to Withdraw Plaintiff's Motion for Default Judgment Against Defendant Ray Telles, Inc. and Motion to Enter Consent Decree. After reviewing the Motion and Consent Decree, the Court finds the following:
