AGREED ORDER

On this day came on to be considered Defendant Parfume de Couer, Ltd., Inc.'s Motion to Compel Answers to Discovery and Plaintiff Equal Employment Opportunity Commission's Response to Defendant's Motion to Compel Answers to Discovery. The Court, after hearing, finds as follows:

IT IS ORDERED that EEOC's objections to Interrogatory No. 9 are overruled. EEOC will provide to the Defendant, within 30 days from the date of this Order, all documents responsive to Interrogatory No. 9.

IT IS ORDERED that with respect to Defendant's Interrogatory No. 10 and Requests for Production Nos. 13 and 26, the EEOC will provide to the Defendant, within 10 days from the date of this Order, the entries in Ms. Cantu's OB/GYN records which relate to Ms. Cantu's discovery of her pregnancy and the confirmation of Ms. Cantu's pregnancy, including when she initially contacted and saw her physician regarding her pregnancy, and the calculation of Ms. Cantu's conception date. All other information on the medical record will be redacted. It is further ordered that, within 10 days from the date of this Order, an identification of the health care providers requested in Interrogatory No.


10 will be provided. The EEOC's objections as to the remaining information requested in Interrogatory Number 10 and Request for Production Nos. 13 and 26 are sustained.



