

NOTICE TO CLASS MEMBERS

On December 27, 2001, this approved the settlement of the Close Management litigation by entering as the Order of the Court, the Revised Offer of Judgment.

The purpose of this Notice is to advise all class members currently assigned to Close Management that the time for filing objections has ended and the Court will take no action on any objections received after December 26, 2001.

The purpose of this Notice is also to advise all class members currently assigned to Close Management that the Court has no responsibility for day to day supervision of Close Management and that you should not contact the Court by letter, or otherwise, to ask the Court for assistance in resolving problems you may experience while assigned to Close Management or other problems you may encounter while in prison. However, if you believe that the Department of Corrections is not implementing

particular provisions of the Revised Offer of Judgment in a fair and good faith manner consistent with its terms, you should use the Department of Corrections' grievance process to bring your particular concerns to the attention of the Department. If your particular concerns are not resolved to your satisfaction, you should advise class counsel of your particular concerns.
