The court being advised that supplemental factual material is required to inform the court and the parties of the current conditions affecting confinement of the Plaintiff Class at the Detention Facility of the District of Columbia Department of Corrections,

IT IS HEREBY ORDERED that defendants file with the court and serve on counsel for plaintiffs, within 21 days of the date of this order, affidavits of the appropriate officials of the Department of Corrections with the indicated information.

A. Population

1. The daily population of the Detention Facility, divided into male and female prisoners, and those housed in the Ugast Center, the infirmary, or the D.C. General Hospital lock ward, from July 1, 1980 through December 31, 1980;

2. Whether any estimates or projections of population of the Detention Facility for 1981 have been made, and the content and basis of such projections.

3. Whether the Detention Facility has on any date since January 1, 1980, exceeded its capacity with regard to either male or female prisoners, and, if so, the number of persons over capacity, the duration of the condition, and any efforts to reduce the population;

• 4. The nature of any plans to expand the capacity of the Detention Facility, or to deal with increases in population beyond the present capacity of the Facility.

B. <u>Psychiatric Care</u>

1. Whether at any time since July 18, 1980, when defendants filed their Report to the Court, there have been less than ten full-time mental health technicians and three full-time psychiatric nurses assigned to the Mental Health Unit, and, if so, the reasons for such staffing levels and duration of such condition;

2. The number of correctional officers assigned full-time on each shift to any units housing mentally ill residents, and whether such staffing levels have fallen below those specified in this court's order of June 9, 1980;

3. The dates and nature of any training provided to staff regarding handling of mentally ill residents;

4. Whether any other residents have access to mentally ill residents, and, if so, under what conditions and with what supervision;

5. The extent to which medical history and records of prior hospitalization and treatment are obtained in a timely fashion;

6. The extent to which each objective stated in the December 1979 Plan for Improvement of Mental Health Services for Inmates of the District of Columbia Adult Detention Facility has been implemented, the reasons for any non-implementation and any plans for further implementation;

7. The nature and status of any plans or proposals to reduce or modify the level of mental health services provided to mentally ill residents of the Detention Facility, including any budget proposals made by the District of Columbia;

B. Defendants should submit copies of any Monthly Status
Reports prepared after the filing of the defendants' April 30,
1980 Report to the Court.

C. <u>Recreation</u>

1. The current indoor and outdoor recreation schedule for each housing unit or class of residents at the Detention Facility;

2. The nature and status of any plans or proposals to modify or reduce the current schedules.

D. <u>Visitation</u>

1. The current regulations and schedule regarding visiting at the Detention Facility and at the Lorton Correctional Complex;

2. The nature and status of any plans or proposals to modify or reduce the current schedules;

3. A description of any classification system currently in effect for residents of the Detention Facility.

E. <u>Discipline</u>

 Copies of the Disciplinary Rules and Procedures currently in effect at the Detention Facility and the Lorton Correctional Complex.
