

The Nevada Department of Employment, Training & Rehabilitation shall not produce records for these individuals;

(2) The subpoenas to the Nevada Department of Employment, Training & Rehabilitation for the records of Christina Barnes, Barbara Bowers-Hughes, Carl Karsgor, Brenda LaFond, Laura Lancaster,

1 Penny Marshall, and Toni Purdy are modified as follows:

2 The Nevada Department of Employment, Training & Rehabilitation shall
