I am writing to inform you of our intention to investigate conditions at Whitten Center ("Whitten") in Clinton, South Carolina. This investigation will be conducted pursuant to the Civil Rights of Institutionalized Persons Act, 42 U.S.C. § 1997 et seq.

The purpose of the investigation will be to determine whether conditions at Whitten violate the residents' federal constitutional and statutory rights. We will be looking at, among other things, resident safety, the adequacy of medical care, training, staffing, the use of psychotropic medication, and issues involving community placement. The initiation of this investigation does not indicate a prejudgment on our part that federal rights have been violated. If any violations are found, we intend to confer with you and your staff concerning any appropriate corrective action.

We would like to initiate this investigation as soon as possible. In that regard, an attorney from my office will contact your staff within the next week to arrange a tour of Whitten by our consultants and Civil Rights Division personnel.
