Other details: People who are named have "next friends" who will help

Parent Guardian Association intervened on the side of the state.

Another lawsuit filed by the Justice Department resulted in a order. Dr. Linda O'Neill is the court appointed special monitor. Our suit had more claims and wants more community relief for the

people there, including their First Amendment rights.

Status: On September 27, 1995 Judge McCalla certified the class to include

anyone who had lived or lives at Arlington or is at risk of living at Arlington since since December 12, 1989 and named People First of

Tennessee as the class representative. He granted intervenor status to People First in the Justice Department case and entered remedial order as a final order in our case. He schedule a hearing on our First Amendment claims for the summer of 1996. Finally, he has not ruled on our motion for further relief. Over 60 people have died at the facility since we began following problems at Arlington.
