Before the Court is Plaintiffs' Motion for Order Requiring Production of Documents Concerning
Defendants' Inmate and Ex-Inmate Witnesses (Clerk's No. 313) filed on November 10, 2005. The
Defendants filed a Response (Clerk's No. 317) on November 14, 2005, which was followed by Plaintiffs'
Reply (Clerks' No. 318) on November 15, 2005. The Court entered an Order (Clerk's No. 316) on
November 10, 2005, in which it set a phone hearing for November 14, 2005, despite stating that
Plaintiffs' "request appears reasonable given the Defendants' use of Department of Corrections and
InnerChange records to impeach Plaintiffs' inmate witnesses during the Plaintiffs' case-in-chief." After
considering the arguments contained in Defendants' Response and Plaintiffs' Reply, the Court has
determined that no further hearing on Plaintiffs' Motion (Clerk's No. 313) is necessary. The Court
considers the matter fully submitted.

In addition to its previous observation that Plaintiffs seem to be merely requesting what was available to Defendants during Plaintiffs' case-in-chief, the Court also finds that the late disclosure of most

of the Defendants' inmate and ex-inmate witnesses precluded Plaintiffs from narrowly tailoring their discovery request for the documents they now seek, which are not voluminous in nature. Accordingly, Plaintiffs' Motion (Clerk's No. 313) is GRANTED.

Defendants shall produce to Plaintiffs all documents in all Department of Corrections and InnerChange files concerning the inmate and ex-inmate witnesses that Defendants have placed on their witness lists (Scott Foster, Kelly Paul, Robert Robinson, Robert Van Zante, Gary Titus, Jesse Weise, Paul Laughlin, Kerry Guy, Jerome Ambers, Brad Longenecker, Steven Six, and Herman Ronnfeldt). Likewise, if Plaintiffs plan rebuttal and there exist documents that would, as well, aid Defendants in their trial preparation, any and all such documents should be produced.

Defendants shall produce these documents to Plaintiffs by November 22, 2005.
