
The Motion was set for hearing on 08/25/2005 at 02:00 PM in Department 22 before the Honorable Ronald M. Sabraw. The Tentative Ruling was published and has not been contested.

**IT IS HEREBY ORDERED THAT:**

The tentative ruling is affirmed as follows: Wal-Mart Store's, Inc.'s and Sam's West, Inc.'s Notice of Motion to Compel Further Responses to their Third Sets of Merits Special Interrogatories and Second sets of Merits Requests for Production of Documents is DENIED.

Having reviewed the discovery requests and the responses thereto the Court determines that Plaintiffs opposition to the motion is well taken. The interrogatories and requests for production essentially would require Plaintiffs to undertake a study and analysis of records and evidence that are equally available to Defendants. CCP Section 2030.220. The Court also finds that Plaintiffs have, subsequent to the filing of these motions, provided Defendants with documents supporting their contentions regarding understaffing problems at Wal-Mart and Sam's West. See Plaintiff's Opposition at page 4, footnote 1. The Court also concludes that Plaintiff's burdensome objection is well taken in light of the impending trial date and time and effort necessary to survey and analyze the voluminous Time Clock Archive Reports.
