MOTION TO RECONSIDER DECISION AND ORDER: DEFENDANT'S MOTION FOR RELIEF FROM JUDGMENT

Plaintiffs hereby move, pursuant to Civil Rule 77(k), for reconsideration of the court's Decision and Order dated October 25, 1993, granting the Department of Corrections' Motion for Relief from Judgment to permanently increase the maximum capacity of Fairbanks Correctional Center by two inmates and Spring Creek Correctional Center by fifty inmates. In reaching its decision, the court overlooked or misconceived material facts that negate the alleged "change in circumstance" that is a precondition for relief from judgment. ARCP 77(k)(1)(ii). The court also failed to consider whether temporary changes in circumstance can justify permanent modification of a final settlement agreement. ACRP 77(k)(1)(i). This motion is supported by the attached memorandum and exhibits.
