Dear Governor Folsom:

I am writing to inform you of our intention to investigate conditions at the Easterling Correctional Facility in Clio, Alabama. This investigation is pursuant to the Civil Rights of Institutionalized Persons Act, 42 U.S.C. § 1997.

The purpose of the investigation will be to determine whether conditions at Easterling violate the inmates' federal constitutional rights. We are concerned with, among other things, prison punishment practices and medical care. The initiation of this investigation does not indicate a prejudgment on our part that federal rights have been violated. Additionally, if any violations are found, we intend to confer with you and your staff concerning any appropriate corrective action.

We would like to initiate this investigation as soon as possible. In that regard, attorneys from my office will contact your staff within the next week to arrange a tour of the Easterling Correctional Facility by our consultants and Civil Rights Division personnel. Dear Governor Folsom:

I am writing to inform you that we intend to investigate conditions at the Julia Tutwiler Prison for Women in Wetumpka, Alabama. This investigation is pursuant to the Civil Rights of Institutionalized Persons Act, 42 U.S.C. § 1997 et seq.

The purpose of the investigation will be to determine whether conditions at the Julia Tutwiler Prison for Women violate the federal constitutional rights of inmates held there. The investigation will focus on, among other things, allegations we have received regarding: (1) medical care, (2) mental health care, (3) physical plant, and (4) overcrowding.

The initiation of this investigation does not indicate a prejudgment on our part that federal rights have been violated. Additionally, if any violations are found, we intend to confer with you and your staff concerning any appropriate corrective action.

We would like to initiate this investigation as soon as possible. In that regard, attorneys from my office will contact your staff within the next week to arrange a tour of the prison by our consultants, Civil Rights Division personnel, and perhaps agents from the Federal Bureau of Investigation.
