

**ORDER DENYING PLAINTIFF'S MOTION TO QUASH SUBPOENA  
DIRECTED TO COMDATA AND LIMITING SCOPE OF REQUEST FOR  
EMPLOYMENT-RELATED DOCUMENTS**

On this day, the Court considered Plaintiff Equal Employment Opportunity Commission's motion to quash Defendant Service Electronics, Inc.'s subpoena for employment-related records regarding Sharon Mejia to a third party, ComData. Having reviewed the motion and considered the arguments of counsel, the Court finds that the motion should be DENIED, but that the scope of the information requested should be limited. It is, therefore,

ORDERED that the Plaintiff's motion to quash is DENIED. It is further

ORDERED that the information requested in the subpoena to ComData will be limited to include any and all employment and personnel records reflecting Sharon Mejia's dates of employment, job title(s), compensation, job performance (including but not limited to performance evaluations, disciplinary actions, attendance issues), reason for separation, job qualifications, job responsibilities, and any workplace accommodations made for Ms. Mejia. It

ORDERED that no documents produced by ComData in response to the subpoena will be used except in the prosecution and defense of the case and those documents will not be disclosed to third parties except on order of the Court. Each party is to bear its own costs associated with this motion.


