According to its memorandum, the MCSO did not participate in mediation due to an unforeseen cost and budgetary concerns. Further, MCSO felt that mediation was not needed since privileged visitation hours were extended to 24 hours per day, seven days per week.

According to the defendants' memorandum, the defense agency is willing to pay its portion of the mediation fee and made other proposals.

The court has contacted the Hon. Kenneth Fields, who is willing to act as Judge Pro Tem in this matter, negating the need for any fee for mediation. Therefore,

IT IS ORDERED appointing the Hon. Kenneth Fields has Judge Pro Tem / Settlement Judge in this matter.

IT IS FURTHER ORDERED that the agencies will contact Judge Fields to schedule a mediation/settlement conference no later than close of business on **January 11**, **2008**.

IT IS FURTHER ORDERED that the mediation/settlement conference shall be held by no later than **January 25, 2008** and that the agencies shall participate in good faith.

IT IS FURTHER ORDERED affirming the court's December 6, 2007 Orders excluding the mediation dates, as have been revised herein.

IT IS FURTHER ORDERED setting a Status Conference on <u>February 1, 2008, at 9:30 a.m.</u>, in this division, to determine what resolutions have been reached in the mediation/settlement conference.

IT IS FURTHER ORDERED that the agencies shall submit separate memorandums by no later than close of business on **January 30, 2008**.
