**ORDER**

The court has received the following documents in two recently consolidated cases listed above: 1) a Stipulated Notice of Voluntary Dismissal With Prejudice (Doc. No. 10, filed January 18, 2002) in Case No. 6:01-cv-1303-Orl-28JGG, and 2) a Notice of Bankruptcy Filing and Automatic Stay (Doc. No. 25, filed January 24, 2002) in Case No. 6:01-cv-1133-Orl-28KRS. After review of the above, it is hereby **ORDERED** that

1. This court's Order of January 16, 2002 (Doc. No. 22) consolidating Case No. 6:01-cv-1133-Orl-28KRS and Case No. 6:01-cv-1303-Orl-28JGG is **VACATED**. Case Nos. 6:01-cv-1133-Orl-28KRS and 6:01-cv-1303-Orl-28JGG are no longer consolidated.

2. The parties' Stipulated Notice of Voluntary Dismissal With Prejudice (Doc. No. 10, filed January 18, 2002 in Case No. 6:01-cv-1303-Orl-28JGG) is **GRANTED with prejudice**. All pending motions in Case No. 6:01-cv-1303-Orl-28JGG are **DENIED as moot**. The Clerk is directed to close this file.

With regard to the parties' Notice of Bankruptcy Filing and Automatic Stay (Doc. No. 25), filed on January 24, 2002, by Defendant Kmart Corporation in Case No. 6:01-cv-1133-Orl-28KRS, such filing acts as an automatic stay of these proceedings as to Defendant Kmart Corporation, pursuant to the Bankruptcy Code, 11 U.S.C. § 362(a). Accordingly, it is **ORDERED** as follows:

1. Case No. 6:01-cv-1133-Orl-28KRS is **stayed** until further order of this court.
2. Defendant Kmart Corporation shall file a status report with this court within thirty (30) days from the date of this order and every ninety (90) days thereafter until the bankruptcy case has been resolved.
