#### Jurisdiction and Venue

- 3. ### **Background Facts**

- 4. Plaintiff was hired by defendant on or about June 2000 as a machine operator in the defendant's lamination department in defendant's Bridgeview, Illinois plant.
- 5. Between June 2000 and January 19, 2001 defendant, by and through defendant's authorized and/or apparent agents, employees and members of defendant's management, subjected plaintiff to sexual harassment and a hostile work environment.
