STIPULATION OF SETTLEMENT OXOGC

Spear v. Waihee

It is hereby stipulated by the attorneys for all of the parties that all pending claims by plaintiffs for reasonable attorneys' fees, costs and expenses are settled in full upon the following terms and conditions:

- 1. The claim for attorneys' fees, costs and expenses submitted by plaintiffs' attorneys as set forth in the letters of July 12, 1985 and July 23, 1985 from Alvin J. Bronstein to James H. Dannenberg, as more fully detailed on the schedules of fees, costs and expenses submitted with those letters, is settled in full for the sum of Two Hundred and Twenty Thousand (220,000) Dollars in fees and Eighty Three Thousand Two Hundred and Fifty Nine (83,259) Dollars in costs and expenses. It is understood that this settlement includes all fees, costs and expenses through and including the entry of the Consent Decree herein on June 12, 1985 and all of the time spent on this fee, costs and expense claim. It is further understood that the defendants will pay all appropriate state taxes on this settlement amount.
- 2. The undersigned attorney for the plaintiffs certifies that he has the authority from all plaintiffs' counsel to enter into this settlement stipulation.
- 3. This stipulation shall be submitted to the Court for the entry of a judgement pursuant to Rule 54, Fed.R.Civ.Pr. in favor of the plaintiffs in accordance with its terms and said judgement shall accrue interest pursuant to 28 U.S.C. Sec.1961.

It is understood and agreed, however, that the defendants will pay this judgement on or about June 15, 1986 and that the plaintiffs will take no action on this judgement unless said payment is not made at that time.

- 4. It is agreed that the settlement amount referred to above shall be paid in one sum to the National Prison Project of the ACLU Foundation, Inc. and that undersigned counsel for the plaintiffs shall be responsible for distribution of appropriate sums to all other counsel.
- 5. It is understood and agreed that this agreement or any payments made in accordance herewith shall not be construed as nor constitute an admission of liability on the part of the defendants.
