

STIPULATED ORDER OF DISMISSAL

THIS MATTER comes before the Court on the stipulated motion of the parties to dismiss this case without prejudice. The Court has reviewed the motion and the Neutral Third Party's Final Monitoring Report and has met with counsel. The Court FINDS that Defendant's have complied with the provisions of the Revised Stipulated Exit Plan and, therefore, the motion should be granted. The Court further finds that, since dismissal is based on the merits this is not a voluntary dismissal or settlement and, therefore, separate notice to the class is not required.






