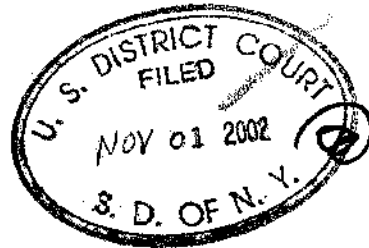

CONSENT DECREE

This action was initiated on June 30, 1999 by plaintiff Equal Employment Opportunity Commission (hereinafter "EEOC"), an agency of the United States Government, alleging that defendant Venator Group, Specialty, Inc., f/k/a F.W. Woolworth Co., Inc., violated the Age Discrimination in Employment Act (hereinafter "ADEA"), by engaging in unlawful employment practices on the basis of age against employees over age 40 ["the Lawsuit"].

The Complaint was amended on March 21, 2002, and is now also amended, pursuant to an accompanying Court-Ordered Stipulation, to substitute "Foot Locker Specialty, Inc., f/k/a Venator Group Specialty, Inc., f/k/a F.W. Woolworth Co., Inc." in place and instead of defendant "Venator Group, Specialty, Inc., f/k/a F.W. Woolworth Co., Inc." (The defendant will hereinafter be referred to as "Foot Locker Specialty").

The parties agree that it is in their mutual interest to fully resolve the Lawsuit without further litigation. This agreement is not an admission of liability by defendant Foot Locker Specialty, its parent company, or any of its predecessor or affiliated companies.

EEOC and defendant Foot Locker Specialty hereby stipulate and consent to the entry of this Decree as final and binding between the parties entering this agreement and their successors or assigns.

This Decree resolves all matters raised or which could have been raised in the Complaint and amendments to the Complaint filed herein.

The parties have agreed that this Decree may be entered without Findings of Fact and Conclusions of Law having been made and entered by the Court.

In consideration of the mutual promises of each party to this Decree, the sufficiency of which is hereby acknowledged, it is agreed and **IT IS ORDERED, ADJUDGED, AND DECREED AS FOLLOWS:**

General Provisions

1. This Decree resolves all of the issues raised by EEOC Charge Numbers attached as Exhibit A and/or the EEOC Complaint (and amendments thereto) referenced above in the Lawsuit. This Consent Decree shall not be construed as an admission by Foot Locker Specialty, its parent company, or any of its predecessor or affiliated companies of any of the acts or omissions of age

discrimination alleged by the EEOC in the Lawsuit or in the underlying Charges of age discrimination referenced above, or of any acts or omissions of age discrimination which could have been alleged therein. Foot Locker Specialty, its parent company, and its predecessor and affiliated companies specifically deny any liability whatsoever for any damages, injuries or other claims alleged by the EEOC, or which could have been claimed by the EEOC in the Lawsuit. This Consent Decree only affects and resolves those charges referred to in Exhibit A and those claimants whom the EEOC represents or could have represented in this lawsuit, and in no way affects the EEOC's right to process any pending or future charges that may be filed against defendant Foot Locker Specialty, Inc., or any of predecessor or affiliated companies in accordance with standard EEOC procedures, and to commence civil actions pursuant to Section 706(f) of Title VII or the Age Discrimination in Employment Act on any such charge.

2. The parties agree that this Court has jurisdiction of the subject matter of this action and of the parties, that venue is proper, and that all administrative prerequisites have been met.

3. No party shall contest the jurisdiction of the federal court to enforce this Decree and its terms or the right of any party to bring an enforcement suit upon breach of any of the terms of this Decree by any other party.

4. Breach of any term of this Decree should be deemed to be a substantive breach of this Decree.

5. Nothing in this Decree shall be construed to preclude EEOC from bringing proceedings to enforce this Decree in the event that defendant Foot Locker Specialty fails to perform any of the promises and representations contained herein.

6. Defendant Foot Locker Specialty and its agents agree not to retaliate against any individual who has participated in this matter or has asserted his or her rights under the ADEA in this matter.

Monetary Relief

7. Within thirty (30) days of the entry of this decree, defendant Foot Locker Specialty shall pay the total sum of three million five hundred thousand dollars and no cents (\$3,500,000.00) in monetary damages (hereinafter "Claim Fund") into Bank of New York, Foot Locker Escrow Account Number 120 305 (hereinafter "Claim Fund account"), which shall be maintained in escrow for the benefit of the claimants in the Lawsuit. The Claim Fund account shall bear interest at the rate in effect at such bank from time to time for commercial, interest-bearing short-term accounts.

All interest earned on the Claim Fund account will be for the benefit of the claimants in the Lawsuit and will be distributed to the claimants.

8. The Claim Fund account shall be opened, maintained and administered by defendant on behalf of EEOC and all claimants in this matter. The EEOC has provided a list of the claimants who will receive monies from the Claim Fund, which list is annexed as Exhibit B.

9. Defendant Foot Locker Specialty shall be solely and completely responsible for independently paying all fees and costs associated with opening, maintaining and administering the Claim Fund account, and may not deduct such costs from the account or from the Claim Fund. Foot Locker Specialty shall also be solely and completely responsible for mailing the payments to the claimants named in Exhibit B.

10. EEOC in its sole discretion shall determine the appropriate amount of monetary relief that shall be awarded to each claimant from the Claim Fund, and the designation of such amounts to be awarded to each person as provided and specified by the EEOC as Exhibit B. Such Exhibit B includes the gross amount to be received by each claimant, together with the last known address of each claimant and the name and address of the personal attorney, if any, for each such claimant.

11. Foot Locker Specialty will make such payments from the Claim Fund so that 50% of the total damage amount to be paid as identified in Exhibit B shall be allocated as wage income with withholding of employee payroll taxes and the payment of employer payroll taxes (including Social Security, FICA, etc.), as required by law. As required by law, Defendant will pay the employer payroll taxes referred to above for that 50% of the gross payment which is wage income. The remaining 50% of the amount identified in Exhibit B shall be paid as liquidated damages. At the end of the calendar year in which payments are made to claimants, Foot Locker Specialty shall issue a Form W-2 relating to any payment paid as wage income and a Form 1099 relating to any payment as liquidated damages. It is understood and agreed that the payment of monies designated herein to the claimants identified by the EEOC and in the amounts designated by the EEOC in

Exhibit B shall not have the effect of recomputing or in any way changing the value or amount of any benefit in which a claimant has a vested interest from Defendant Foot Locker Specialty, its parent company, or any of its predecessor or affiliated companies.

12. It is understood that claimant distribution checks may be returned to Defendant if the mailed check does not reach a claimant at the address provided by the EEOC, and that Defendant Foot Locker Specialty will provide the EEOC with any returned envelope regarding each such claimant. It is also understood that in such event or other event, it is possible that a claimant will not cash the check payments designated in Exhibit B for that individual. It is understood and agreed that any such sum remaining in the \$3,500,000 Claim Fund shall not serve to increase Foot Locker Specialty's total monetary obligation in connection with this Consent Decree, which is as follows: (i) \$3,500,000 to be deposited into the Claim Fund account, as provided in ¶ 7 above; (ii) interest earned on the Claim Fund account, as provided in ¶ 7 above; (iii) costs and fees associated with the maintenance of said Claim Fund, and the costs and fees of mailing such payments, W-2, and 1099 Forms, as provided in ¶¶ 9, 11 above; and (iv) the payment of payroll taxes, as provided in and so limited by ¶ 11 above.

13. At such time as the EEOC notifies Defendant of its intention to distribute the balance of the Claim Fund, Defendant, upon request by the EEOC, will inform the EEOC as to the remaining amount in the Claims Fund (including the amount of any uncashed checks, plus the accrued interest), and EEOC will provide to Foot Locker Specialty Exhibit C designating the amount of money to be

paid to each claimant identified in that Exhibit. The amounts designated for payment by Exhibit C shall be paid in the same manner as described in paragraph 11.


14. Upon any payment made pursuant to ¶11 or 13, Defendant Foot Locker Specialty will provide to the EEOC copies of the checks sent to the claimants listed in Exhibit B and C. Defendant will also provide copies of the W-2 and 1099 Forms mailed to each claimant listed in Exhibit B and C.

Miscellaneous

15. This Decree constitutes the complete understanding among the parties. No other promises shall be binding unless agreed to in writing and signed by these parties.


16. This Decree will remain in effect for three (3) years from the date of entry.
