This Motion has been pending before the Court since the inception of this lawsuit. This court as stated at the hearing on 11/12/93 is never quick to certify a class action and therefore offerred to counsel the opportunity to stipulate as to certain issues to be presented on appeal in lieu of certifying a class at this stage in the lawsuit. Notice having been received by the Court that the defts do not wish to stipulate any issues the court enters the following findings and conclusions regarding class certification. It is ORDERED AND CERTIFIED that all federally incarcerated inmates serving their period of incarceration in a federal penal or medical institution be and the same are hereby certified as members of a nationwide class of pltffs prosecuting this lawsuit. The court finds that questions of law and fact, common to the members of the aforesaid class, predominate over any questions affecting only individual members and that therefore a class action is superior to any other available method for the fair and efficient adjudication of this controversy. Court specifically finds the class of all federally incarcertaed inmates as herein described meets the numerosity prerequisite. Court finds that factual questions pertaining to the harm to inmates by virtue of the ITS and legal questions pertaining to the trust funds, Communicaitons Act and constitutional rithst are common issues to be litigated as to all members of the certified class. Further the court finds that the pltffs in this lawsuit have brought claims typical of the class and will fairly and adequately represent and protect the interests of the class. Court notes that defts have claimed the pltffs in this lawsuit do not represent the interests of the entire class as herein certified. Court believes, however, there is adequacy of representation. The proof in this

		case reveals that while some inmates may prefer the ITS over a collect-call system and a system that complies iwth the law. All inmates deisre what the pltffs seek in this case, i.e., a dual collect-call and direct-dial system. The court furthermore concludes that certification is proper in this case in any event because the defts have taken actions of general application toward the entire class herein certified. In this circumstance, certification is proper even if a few members are saisfied with the ITS as opposed to some other system. This is true since all members of the certified class have the smae legal interest in the proper application of the federal laws and the trust terms implicated int his case. Court therefore concludes that this action shall proceed as a class action. Relief sought by the representative pltss is predominantly injunctive and declaratory in nature and the actions of the defts have been taken toward the members fo the pltffs class such that inconsistenet or varying adjudications iwth respect to any individual member of the class would establish incompatible standards of conduct for the defts; moreover, a jdugment in this lawsuit would as a practical matter be dispositive of or substantially impari or impede the itnerest of all federal inmates whether or not joined as parties to this action. Court notes that 2 inmate actions raising some of the issues brought by the representative Pltffs herein are currently pending in Kansas and Georgia.
