The race—based provisions are no longer needed to address past discrimination and are, consequently, unconstitutional. Therefore, the City's motion for extension of time to comply with the Headen Decree, the Vanguards of Cleveland's motion to extend the terms of the Second Amended Consent Decree, and the Vangard's renewed motion to extend are denied.
