- (1) The injunction entered on January 17, 2003 is HEREBY VACATED;



4 Ali Ali, Mohamed Aweys, and Mohamed Hussein Hundiye are HEREBY  
5 DISMISSED WITHOUT PREJUDICE;
- 6 (4) The Summary of Proceedings and Status of Case (the "Notice") currently  
7 posted to the Court's website and the subject of the Court's prior Orders  
8 regarding notice to detained class members is hereby modified as indicated  
9 in the attachment to this Order (the "Final Notice");
- 10 (5) The Notice currently posted to the Court's website shall be removed and  
11 replaced with the Final Notice;
- 12 (6) The Final Notice shall remain on the Court's website for the next 90 days;
- 13 (7) Counsel for Petitioners shall have the Final Notice promptly translated into  
14 Somali and shall promptly provide a copy of the translated Final Notice to  
15 the Court and counsel for Respondents; and
- 16 (8) Within 20 days of receipt of the translated Final Notice as provided under  
17 paragraph 7 above, the Government shall serve both the English and Somali  
18 versions of the Final Notice on all persons with final orders of removal to  
19 Somalia currently in detention.
