STIPULATION TO TERMINATE PROSPECTIVE RELIEF REGARDING HEAT ABATEMENT

The parties, through counsel, stipulate to the following to resolve the heat and temperature issue in this litigation:

RGC's Cool Dome Operations

- 1. RGC Charles E. Egeler Reception and Guidance Center (RGC)
 Operating Procedure entitled "Cool Dome Operations", OP-RGC-03.04.100-A,
 (Stipulation Attachment 1) has been modified effective May 9, 2012 to have
 language consistent with the modified form and rules used in the RGC Cool Dome operation. The form and rules are attachments to OP-RGC-03.04.100-A and are included with this Stipulation as Stipulation Attachment 1-a (Notification of Heat Alert Conditions Prisoner Choice) and 1-b (Cool Dome Prisoner Rules).
- 2. The Defendants have modified the form used to record a High Risk of Heat Related Illness (HRHRI) prisoner's choice to go to the Cool Dome or stay in the cell block during a heat alert, so that the form is entitled "RGC Prisoner Notification of Heat Alert Conditions, Prisoner Choice" (instead of "RGC Prisoner Notification of Conditions, Prisoner Waiver").

- 3. The Defendants have added the phrase "including inhalers" to the list of items that may be taken to the Cool Dome by a HRHRI prisoner choosing to go to the Cool Dome during a heat alert. The Cool Dome prisoner rules have also been modified to ensure that if a prisoner's disabilities prevent him carrying his prescribed medications or personal hygiene items to the Cool Dome, those items will be transported for him to the Cool Dome.
- 4. The Defendants have confirmed, by memorandum dated May 10, 2012 (Attachment 2), that RGC HRHRI prisoners who choose to go to the Cool Dome during a heat alert shall not be terminated from any assignment they may have or receive any assignment demotion or other assignment sanction.
- 5. The term of this Stipulation shall be two years from the date it is entered by the Court.
- 6. During the period of time the agreement is in effect, the Plaintiffs may continue to monitor the Defendants' compliance with order(s) relating to heat and temperature. However, the Defendants shall not be responsible for Plaintiffs' attorney fees and Plaintiffs' costs, including Plaintiffs' expert costs and fees, related to Plaintiffs' monitoring of Defendants' compliance with order(s) relating to heat and temperature.
- 7. During the term of this Stipulation, the MDOC shall maintain the Cool Dome as a continuous place of refuge during heat alerts, defined as the time during which one or more galleries in one or more cell blocks of RGC register a Heat Index (HI) of 90 or higher, and shall otherwise comply with the terms of this Stipulation.

8. The parties agree that this Court's June 5, 2007 Opinion (Dkt. No. 2466) and Order (Dkt. No. 2467) shall be terminated and of no further prospective effect as of the expiration of this Stipulation.

OBJECTIVE:

To establish a procedure of prisoner placement in the Cool Dome.

AUDITING:

The Warden has responsibility for ensuring this procedure is complete and accurate. This responsibility includes: 1) ensuring the procedure complies with all applicable Department administrative rules, policies, DOMs and procedures; 2) reviewing the procedure at the time of annual review; 3) submitting draft revisions when the procedure needs updating; and, 4) auditing staff compliance.

FORMS:

Notification of Heat Alert Conditions - Prisoner Choice – Attachment A Order – Everett Hadix, et al. v. Patricia Caruso, et al. Case No. 4:92-CV-110 Cool Dome Prisoner Rules – Attachment B

INFORMATION:

Prisoners who are designated as High Risk for Heat Related Illness (HRHRI) will be afforded the opportunity to move to the Cool Dome during periods of a declared heat alert.

Prisoners in the Special Management Housing Unit (SMHU) for medical reasons and who are on the HRHRI list will be escorted to Duane Waters Health Center (DWHC).

Showers will be provided to prisoners in the Cool Dome after evening meals.

When the Cool Dome is occupied, prisoners will be released to Food Service as a unit.

Cool Dome staff will ensure intake processing takes place without interruption,

A medical kite box will be provided. Medical professional, nursing call-outs and medication lines will be conducted as normal.

Each housing unit will monitor heat index readings during regular rounds (at least hourly). The Heat Index reading (example: Heat Index 80) will be recorded in the respective logbook at the same time the round is noted.

The portable Heat Index Monitor shall remain set to alert staff whenever the Heat Index reaches 90 degrees. Whenever staff notes a Heat Index of 90 degrees or higher, the control center shift commander will be contacted. The reporting unit staff member should note in the logbook the time of notification and who was contacted.

When not in use, the portable Heat Index Monitor will be secured in the officer's station cutter box.

Housing unit staff shall account for the Heat Index Monitor and its working condition at the beginning of each shift in the same manner as keys, radio and cutter knives.

ATTACHMENT B

COOL DOME PRISONER RULES

The Cool Dome is a specialized unit equipped to hold prisoners during periods of Heat Alert conditions. Prisoners will remain assigned to the Cool Dome only while Heat Alert conditions are in effect.

ALL RGC Housing Unit Rules apply unless otherwise noted here.

Prisoners may take the following articles into the Cool Dome with them as long as they are able to carry them:

- ✓ Reading materials
- ✓ Necessary medications
- ✓ Daily hygiene items
- ✓ Legal/writing materials
- ✓ One Pair Underwear
- ✓ One Pair Socks
- ✓ Inhaler
- Prisoners must remain in their assigned area while in the Cool Dome unless otherwise authorized by staff.
- Prisoners must have authorization from staff to use the bathroom facilities.
- Prisoners may leave the Cool Dome for meals, yard and other activities as authorized.
- Prisoners shall remain on their assigned bunk during count times.

When Heat Alert is cancelled, prisoners shall report directly back to their assigned housing unit. All property must be taken back to the prisoner's cell.

No personal property shall be stored in the Cool Dome when the prisoner returns to his cell after the heat alert is cancelled.
